# PGS MANUAL DEVELOPMENT FOR GACAVARI SHG



The process of Participatory Guarantee System (PGS) development for Gacavari SHG–an ADS MKE farmer group made a remarkable progress on the 28th and 29th June 2016. Gacavari SHG works group was started in 2013 with a membership of 20 people. The focus value chain in the PGS certification process is the indigenous chicken.

On these dates, the group was further trained on understanding and conceptualizing the organic farming process PGS development. The group specifically developed the group PGS rules and sanctions, developed an action plan and signed in to a PGS pledge form.

The PGS certification will enhance the group's engagement in the organic market sector.

The group is grateful for continued support by PELUM Kenya and ADS MKE.

PELUM Kenya is also working with three other farmer groups in the PGS certification process.

The delegation was led by Ms. Monika Pepping, the Programme Officer Bread for the World and Ms. Esch Anja, the Programme officer in charge of advocacy at Bread for the world. The group visited the Ti-kwenda Kwitu Self-Help Group in Kavaini Village, Mwingi. This is a group of 11 members (7men and 4 women) who are working closely with Kitui Development Centre (KDC), one of the members in the Lower Eastern and Coast Zone. Ti Kwenda Kwitu SHG lauded the efforts made by KDC and PELUM Kenya in improving their livelihoods. The visiting team was happy to note the coping mechanisms employed by the farmers in adapting to climate change impacts. The visitors were also impressed by PELUM Kenya and KDC's success in working with the farmers.
